<u>ITEM NO.1</u> Confirmation of the Minutes of the 94th meeting of the Executive Council held on November 30, 2009.

The minutes of the 94th meeting of the Executive Council of the International Institute for Population Sciences held on November 30, 2009 was circulated and as there was no objection from the members, the minutes were confirmed.

ITEM NO.2

Action taken on the decisions of the 94th meeting of the Executive Council held on November 30, 2009.

Action taken on the decisions of the 94th meeting of the Executive Council held on November 30, 2009 was noted.

Sub-Item No.6 (E.C. 93): Approval for running Department of Extra Mural Studies on yearly basis and sanction of Expenditure for the year 2009-2010: While discussing about running of the department of Extra Mural Studies, the Chairman emphasized about the evaluation pattern of the distance education course and suggested that if felt necessary modifications may be done to attain better quality of distance education programme. The Director briefed that the Institute has maintained the quality of Distance Education Programme just like regular courses by following continuous evaluation, viva-voce written examination, etc. The Institute is also in the process of preparing audio-video teaching learning material for the students, and the students are being given four years for completion of the course. It was decided that while the funding for the Department would be approved for the current financial year, the Institute would submit a proposal for evaluation of the correspondence courses being run by the Department. This evaluation would be done by an external agency selected by a tendering process and cover various aspects like the popularity and utility of the course, its acceptability by various recruiting institutions, interview of the alumni, recommend proper assessment procedure with online education, examination, evaluation and assessment etc. The IIPS is to also explore the feasibility of using the faculty and resources of the 18 Population Research Centres of MoHFW for the contact classes for the courses.

Sub-Item No.8 (E.C.93): Approval for amendment to be made in the Recruitment Rules in respect of appointment to the post of Data Entry Operator Gr.'B' and Data Processing Assistant Gr.'B': The post of Data Entry Operator Gr.'B' has been advertised according to the new Recruitment Rules. The members were informed that sufficient number of application were received in response to the advertisement. It was also decided that IIPS may fill up these vacancies on priority.

Sub-Item No.9(A) (E.C. 93): Approval of Recruitment Rules to the post of Assistant Registrar (Administration) and Junior Accounts Officer: The post of Jr. Accounts Officer has been filled by promotion and the matter for filling up the post of Assistant Registrar (Administration) is kept as a separate agenda item in the current Executive Council meeting.

Sub-Item No.9(B) (E.C. 93): Pay revision of employees of Quasi-Government organizations, autonomous bodies, etc., set up by and funded/controlled by the Central Government: The minutes of the meeting held on February 07, 2011 is placed under any other matters and the recommendations will be sent to the Ministry for approval.

<u>Sub-Item No.11 (E.C. 93):</u> Reporting of matters to the <u>Executive Council:</u> Some of the task force recommendations were discussed on which action have been taken. It was noted that a timeline for the implementation of the recommendations may be drawn up by the Institute and closely monitored.

ITEM NO.3:

Recommendation for adoption of the Annual Report for the year 2009-2010.

The Executive Council considered the Annual Report of the Institute for the year 2009-2010 and recommended for adoption by circulation among the members of the General Council of the Institute.

ITEM NO.4:

Approval for running the Department of Extra Mural Studies on yearly basis and sanction of Expenditure for the year 2010-2011.

The members considered the proposal submitted for running the Department of Extra Mural Studies for the year 2009-2010 and approved the same. While discussing about the running of the department of Extra Mural Studies, the Chairman emphasized about the evaluation pattern of the distance education and suggested that if felt necessary modifications may be done to attain better quality of distance education programme. The Director briefed that the Institute has maintained the quality of Distance Education Programme just like regular courses by following continuous evaluation, viva-voce and written examination, etc. The Institute is also in the process of preparing audio-video teaching learning material for the students, course material to be developed

on par with UNFPA/JHU, IUSSP, etc., and the students are being given four years time period to complete the course. As already indicated under Sub-Item No.6 in Agenda Item No. 2 above, it was decided that while the funding for the Department would be approved for the current financial year, the Institute would submit a proposal for evaluation of the correspondence courses being run by the Department. This evaluation would be done by an external agency selected by a tendering process and cover various aspects like the popularity and utility of the course, its acceptability by various recruiting institutions, interview of the alumni, recommend proper assessment procedure with online education, examination, evaluation and assessment etc. The IIPS is to also explore the feasibility of using the faculty and resources of the 18 Population Research Centres of MoHFW for the contact classes for the courses.

ITEM NO.5:

Approval for continuation of the research projects initiated during the year 2009-2010 and new research projects to be undertaken during the year 2010-2011 - Recommendations of Academic Council.

Director & Sr. Professor, IIPS gave a brief idea of the completed and continuing projects of IIPS. Of the three new projects recommended by the Academic Council, Project No.2 and 3 were approved and Project No.1 was not approved by the Committee. The Chairman advised that while qualitative research work should be carried out and more review should be taken while the projects work is going on so as to complete the project in time, as it was noted that many projects are not completed in time. It was decided that a mechanism be set up for regular monitoring of the various projects undertaken by the Institute to oversee the

progress vis-à-vis the timelines, costs involved and whether extension of such projects has the concurrence of the sponsoring agency. It was also decided that if Executive Council meeting could not be held in time, the copy of new research projects approved by Academic Council should be circulated among the Executive Council members for remarks and approval in future.

ITEM NO.6:

Approval of Revised Estimates for the year 2010-11.

The Executive Council based on the recommendations of the Standing Finance Committee approved the Revised Estimates for the year 2010-2011 as follows:

Rs.18.90 crores

While discussing the Revised Estimates for the year 2010-11 it has been pointed that Rs.4.00 crores to be released by the Ministry cannot be utilized before 31st March 2011 since CPWD are working on restructuring of all the buildings of IIPS, and work can only be initiated after receipt of their report. It was suggested that more possibilities should be explored by the administration for getting the BMC related works completed for the infrastructure development project at the Institute. The Institute was advised to expedite the work relating to obtaining clearances for the upgradation plan and the DPR to get it completed by the end of

this financial year, that is 2010-11. The Institute could also make involve the Ministry in expediting clearances from the State Government authorities as necessary.

ITEM NO.7:

Approval of Budget Estimates 2011-2012.

The Executive Council considered and approved the Budget Estimate for the year 2011-2012:

The Institute was advised to closely monitor the pace of expenditure so that the funds allocated to the Institute do not lapse.

ITEM NO.8:

Reporting of matters relating to Academic Section.

The Executive Council on the recommendations of the Director, IIPS ratified the extension of the fellowship of Ms. Soumya Mohanty, Mr. Mahesh Nath Singh and Ms. Nandita Saikia for a further period of six months w.e.f. January 17, 2010, April 26, 2010 and May 09, 2010 respectively as a special case. For future it was decided that the Institute may follow the UGC norms for granting extension based on their academic performance and such proposals may be first approved by the Academic Council, followed by the Standing Finance Committee and Executive Council.

ITEM NO.9:

Approval of Recruitment Rules for the six new Faculty posts.

For the Recruitment Rules for the posts of Professor, Associate Professor and Assistant Professor it was decided that the RRs be aligned to the UGC guidelines for such posts for all levels along with an on going assessment (API). The essential qualifications in the RRs may also include Life Sciences / Environmental Sciences in place of Zoology. (Annexure-I)

ITEM NO.10:

Reporting of matters related to Administration.

The Executive Council noted the reporting of matters related to administration as contained in the agenda note.

ITEM NO. 11:

ITEM NO.12:

Extension of term of appointment of Authorized Medical Attendant, Retainer Lawyer and Consultant Engineer of IIPS, and Enhancement in the Monthly Honorarium of Authorized Medical Attendants.

ITEM NO.13:

Permission to fill up the post of Assistant Registrar (Administration).

The Executive Council approved to fill up the post of Assistant Registrar (Administration) at IIPS strictly in accordance with the qualifications and conditions prescribed by the UGC. The advertisement for recruitment to this post may be widely publicized to get good candidates and the performance of the incumbent be monitored.

ITEM NO.14:

Approval to count the past services of Dr. Aparajita Chattopadhyay, Assistant Professor.

The Executive Council approved the counting of past services of Dr. Aparajita Chattopadhyay rendered in Banaras Hindu University to be regulated as per Government of India guidelines for inter- university transfers.

ITEM NO.15:

To approve the Revised Recruitment Rule of Multi Tasking Staff.

The Executive Council approved the revised Recruitment Rule for the post of Multi Tasking Staff to be as per the model RRs of DOPT. The institute is to separately identify activities that could be outsourced.

ITEM NO.16:

To approve the Revised Recruitment Rule to the post of Lower Division Clerk.

The Executive Council approved the revised Recruitment 232Rules for the post of Lower Division Clerk to be as per the model RRs of DOPT including the age limit to be kept as 18-27 years. The advertisement for recruitment to this post may be widely publicized to get good candidates. (Annexures – II & III).

ITEM NO.17:

To approve modification in the Recruitment Rule to the post of UDC-cum-Cashier.

The Executive Council approved the modified recruitment Rule and to fill up the post of UDC-cum-Cashier as per amended recruitment rule i.e. by direct recruitment. (Annexure IV). The advertisement for recruitment to this post may be widely publicized to get good candidates.

<u>ITEM NO.18:</u>

Approve Pay Scales and Upgradation schemes as per UGC Notification to the post of Vice-Chancellor/Director, Registrar, Librarian, Finance Officer/Accounts Officer, Assistant Registrar, Controller of Examination.

The Council noted that having regard to the fact that the posts of Director and Registrar are of permanent status in IIPS whereas as per the UGC Regulations these have to be for a fixed tenure. It was, therefore, agreed that all the implications of a shift to UGC Scales for such posts need to be carefully examined by a committee in the Ministry with a representative of the Ministry of HRD. The Committee may furnish its report within a fixed time-frame, say three months. Accordingly IIPS should send a proposal to the Ministry for constitution of the Committee to consider the case for up gradation of pay scales.

ITEM NO.19:

Reporting of İmplementation of Task Force recommendations at IIPS.

Director briefed about the implementation of Task Force recommendations at IIPS. As per the Task Force report the Institute has obtained '0' marks for administrative (governance) set up. Director

briefed that as per the Task Force recommendations discussion were held with the faculty members for restructuring the departments and the action taken have been submitted along with this agenda. A separate Project Cell was recommended by the Task Force committee and accordingly a budgetary requirement of the resource persons has been put up in the agenda. The EC has approved the proposal "in principle" to set up a 'Project Cell' and the matter has to be put up in the next Standing Finance Committee meeting. The requirements of the resource persons depends upon the projects run by IIPS, and a strategy has to be framed for all these issues related to 'Project Cell'. The Director informed the members that at present the Institute is having different projects engaging number of resource persons on consolidated salary. The funds available under these projects will be collected and accumulated under one head/account and then the expenditure will be incurred for these resource persons. In addition to this overhead charges are also available for this. After creating the 'Project Cell' detailed guidelines will be framed for the functioning of this project. The members of the Executive Council have suggested to rename the 'Project Cell' to 'Project Support Cell' or 'Project Support Unit' and the staffing pattern for this Unit would be based on the number of projects in hand, duration, importance/ priority, availability of funds etc. The designations of the various positions in this Unit are to be redesignated to Project Coordinators and Project Managers. As the staff strength would vary from time to time, the Institute will constitute a committee to oversee these activities and accordingly decide on the staff strength. The EC, in principle approved the proposal to include the funding of the activities of this Project Support Unit in the budgetary estimates while seeking funds from various agencies. The Chairman advised to give the list of publications of the faculties in response to discussion on Pt. 4.3.2 on Page No.242. The Director informed that on an average 1.7 i.e. 2 publications per faculty is the research outcome of the institute and also we are placing these information on the Institute's website. The Chairman has advised that Director should give minimum target to all the faculty members for peer-reviewed publications every year to review their performance based on the UGC pattern. The Director assured that the details of the publication of all the faculties will be submitted in the next meeting.

ITEM NO.20:

Reporting of matters to the Executive Council.

- (a) Action has been taken for grant of MACP to Non-Faculty Group 'B' and 'C' employees of IIPS and a committee will be formed for Group 'A' employees as per provisions contained in the Bye-Laws of the institute.
- (b) As requested by the Institute, the Executive Council approved to include the name of Shri L.P. Srivastava, Retd. Additional Director General, CPWD as Project Advisor in the Project Management Committee (Construction Committee) of IIPS.

ITEM NO.21:

Any other matter with the permission of Chair.

The minutes of the meeting held on February 07, 2011 for implementation of pay revision of the posts as per the provisions enlisted in Part B section I & II was discussed, and it was decided to refer the matter to the Ministry. It was also noted that the IIPS needs to attract and retain the best talent in its faculty, for which it was

decided that the advertisement for recruitment to vacant posts would be widely publicized through print and electronic media in leading newspapers, magazine and e-mails sent to leading universities and research institutions.
