MINUTES OF THE MEETING OF THE BOARD OF STUDIES AND RESEARCH OF THE INTERNATIONAL INSTITUTE FOR POPULATION SCIENCES HELD ON 10TH NOVEMBER 2020

A Meeting of the Board of Studies and Research was held online on 10th November 2020 at 11.30 AM chaired by Prof K.S. James, Director and Senior Professor, IIPS. All members joined the virtual meeting. At the outset, the chairman extended warm welcome to all members and external experts to the meeting of Board of Studies and Research (BOSR).

Prof. R.B.Bhagat, Research Co-ordinator presented the agenda of the meeting.

1. AGENDA 1: To confirm minutes of the meeting of Board of Studies and Research held on October 11, 2019.

The members confirmed the minutes of the meeting of BOSR held on October 11, 2019.

2. AGENDA 2: The revision of course structure of MA/MSc Programme with specialization

Director & Sr. Professor has constituted a committee to revise the course structure of MA/MSc programme. The committee suggested three specialization such as (a) Survey Research and Data Analytics, (b) Public Health, and (c) Population Geography. The report of the committee was placed for the consideration of BOSR. The chairman of the committee Prof. S.K. Mohanty has presented the recommendations of the committee in brief. He explained that the suggested restructuring is prepared based on the criteria such as employability of students, expertise within IIPS and possibility of expanding opportunity at university and college levels. The recommendations of the committee were on the whole appreciated by BOSR members with few suggestions. For example, the recommendations must align with the UGC syllabus on Population Studies. The credit of the courses should be either of 2 or 4 credits. The specialization of Survey Research and Data Science should also include some of aspects of social theories and issues. It is also suggested that the specialization of Population Geography should be renamed as 'Population and Settlement Geography' to widen its scope. The BOSR recommended that the recommendations be placed before Academic Council for final approval.

3. AGENDA 3: Discontinuation of Master of Philosophy in Population Studies/Biostatistics and Demography Course from the Academic Year 2021-2022.

The New Education Policy of the Government of India suggests discontinuation of M.Phil programme and admitting students directly to Ph.D after Master's Degree. The BOSR discussed on coninution of MPhil program at IIPS from 2021-22 Academic Year.

It is decided to discontinue M.Phil Programme from 2021-22. The external experts suggested to strengthen the Pre-PhD programme extending it from presently imparted for one semester to 2 to 3 semesters. Preparation of a research paper along with research proposal may be included as a part of pre-Ph.D.programme. It is also suggested to constitute a committee to look into issues for improving the Ph.D. programme.

4. AGENDA 4: Ph.D Re-Registration Fee Schedule

The Academic Council in its meeting held on April 28, 2017 had approved the proposal of Reregistration for a maximum period of two years for Ph.D. Accordingly, the fee structure for Reregistration of Ph.D students is being placed for the consideration of BOSR.

Prof. R. Nagarajan presented Ph.D. Re-Registration Fee Schedule as proposed by Academic Section. The maximum duration of re-registration period should be two years on the recommendation of Advisory Committee with 6 months duration at a time. The BOSR recommended to place the matter to Academic Council for further approval.

5. AGENDA 5: Part-time Ph.D Fee Structure

As approved by the Academic Council in its meeting held on 03/12/2019, the Institute has introduced Part-time Ph.D.programme from the Academic Year 2020-2021. Accordingly, the fee structure for the Part-time Ph.D programme is placed here for the consideration of BOSR/AC.

PART-TIME PHD. PROGRAMME IN POPULATION STUDIES /

The BOSR recommended the fee structure to be placed in the Academic Council. It was observed that fee for foreign students are very high in the Institute. The BOSR suggested to look into the matter keeping in view students from SAARC countries and place the revised fee structure in Academic Council for its consideration and approval.

6. AGENDA 6: Reporting of following matters regarding measures adopted during the Covid-19 period for the academic programmes of IIPS:

- (i) Final Semester examinations for the Academic Year 2019-2020
- (ii) Admissions for the Academic Year 2020-2021
- (iii) Online classes for the Academic Year 2020-2021
- (iv) First Semester examinations for the Academic Year 2020-2021

The BOSR was briefed by Prof. R. Nagarajan, In-charge of Examination and Academic Section on the above issues. He informed that the Institute has followed the guidelines issued by the UGC from time to time regarding online classes and conducting examination. In this light Institute has

taken decisions after holding meeting with faculty. It is suggested to place the decisions before Academic Council for its information.

7. AGENDA 7: To review the progress of internally and externally funded research projects of the Institute.

The progress of eight internally funded projects was reported to the BOSR. It is observed that there is a delay in completion of some of the projects. Reason for the delay is either lack of suitable staff available or there is an attrition of project staff. Covid 19 and lockdown also led to delay in the projects. The project co-ordinators may ensure that projects are not delayed further. It was also suggested that while reporting the progress or completion of projects, the project co-ordinators may also intimate if any paper is published or presented out of the project work.

It is brought to the notice that the Institute has created a Project Support Cell to facilitate the project work. It is required that the Co-odinators/PIs of the Project should get their budget approved routed through project cell and submit a copy to the Account Section.
