ABOUT THE INSTITUTE

The International Institute for Population Sciences (IIPS) Mumbai, formerly known as the Demographic Training and Research Centre (DTRC) till 1970, was established in July 1956 under the joint sponsorship of the Government of India, Sir Dorabji Tata Trust, and the United Nations. The Institute is under the administrative control of the Ministry of Health and Family Welfare, Government of India.

The Institute serves as a regional centre for Training and Research in Population Studies for the ESCAP region. The Institute was re-designated to its present title in 1985 to facilitate the expansion of its academic activities and was declared as a 'Deemed University' in August 14, 1985 under Section 3 of the UGC Act, 1956 by the Ministry of Human Resource Development, Government of India. This recognition has facilitated the award of degrees by the Institute itself and paved the way for further expansion of the Institute as an academic institution. The faculty members and the supporting staff belong to diverse interdisciplinary background with specialisation in some core areas of population sciences, trained in India and abroad.

The Institute is the hub of population and health related teaching and research in India, playing a vital role for planning and development of the country. During the past years, students from different countries of Asia and the Pacific region, Africa and North America have been trained at the Institute. The alumni of the Institute are occupying prestigious positions at reputed national and international organisations, universities, research institutes and non-governmental organisations.

The Institute offers Post-Graduate, Doctoral, and Post-Doctoral courses, admission to which for the academic session 2025-2026 is announced hereby. After completing the course, students of all programmes are well prepared for: (i) admission to higher degree programmes in the best universities of the world; (ii) a good career in teaching & research; (iii) multi-disciplinary professional career; or (iv) independent consultant and specialist in health and development sectors.

General Information

- 1. Reservation for SC/ST/OBC/PWD/EWS may be considered as per the Government of India norms only. The format of SC/ST/OBC/PWD/EWS/KASHMIRI MIGRANT CERTIFICATE is given in Annexures. The candidates are required to submit the respective valid category certificate at the time of admission.
- 2. The candidates provisionally selected under EWS and OBC-NCL category are required to submit the valid certificate issued **on or after 01 April 2025** by the competent authority. If the candidate fails to submit the valid certificate at the time of admission his/her candidature will stand cancelled with immediate effect and no further request will be entertained.
- 3. Duration of Ph.D. programme is specified for thesis submission and not for fellowship.
- 4. Government of India Fellowships @ Rs. 37,000/-per month for 1st and 2nd years and Rs. 42,000/-per month for 3rd and 4th years available for the Indian students who have qualified NET for Lectureship in Population Studies or its inter-disciplinary subjects conducted by the UGC. Such Ph.D. fellowship also carries a contingency grant of Rs. 10,000/- per year for the first two years and Rs. 20,500/- for the third year.
- 5. Candidates who have already passed the qualifying examinations and those who have already appeared/ shall be appearing in the final qualifying examinations are eligible to apply. However, admission of the candidate will be cancelled if she/he fails to furnish the final examination results by **September 30, 2025.**
- 6. Eligibility for admission can be relaxed by the Admission Committee in exemplary conditions.
- 7. If any student desires to withdraw admission after paying the course fees, the refund of course fees will be as per the Institute's rule.

Eligibility: Candidates with minimum qualification of Bachelor's degree (NCrF Level-5.5) from a recognized university in India or abroad in any subject with a minimum of 55% marks (50% for reserved candidates) of aggregate marks/equivalent grade in all subjects will be eligible for admission.

Candidates who have already passed the qualifying degree examinations and those who have already appeared/shall be appearing in the final qualifying examinations are eligible to apply. However, the admission of the candidate will be cancelled, if s/he fails to furnish final result by **September 30**, **2025**.

The upper age limit is **25 years** as on **June 30, 2025**. Marks and age will be relaxed for candidates belonging to SC/ST/OBC/PWD categories as per Government of India rules only.

Duration: Two years (Full-Time)

Fellowship: Each selected Indian student will be awarded a Government of India Fellowship @ Rs. 5,000/- per month.

4. DOCTOR OF PHILOSOPHY IN POPULATION STUDIES (Ph.D.)

No. of Seats: Total vacant seat of GOI fellowships on the date of advertisement.

In case of JRF candidates, the Admission Committee may decide the number of candidates to be selected based on the performance in the personal interview. In no case, any JRF candidates scoring less than the last respective category of GoI candidate selected for Ph.D. program be selected.

Eligibility: (1) Candidates who have completed:

I. A 1-year/2-semester master's degree programme after a 4-year/8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institution.

A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the UGC from time to time.

Provided that a candidate seeking admission after a 4-year/8-semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the UGC from time to time.

OR

II. Candidates who have completed the M.Phil. programme with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of educational institutions, shall be eligible for admission to the Ph.D. programme.

A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the UGC from time to time.

AND

(1) Those clearing in UGC-NET (Subject as mentioned below) in any of three categories are eligible to apply for the admission to Ph.D. programmes:

Category-1: Eligible for (i) admission to Ph.D. with JRF and (ii) appointment as Assistant Professor.

Category-2: Eligible for (i) admission to Ph.D. without JRF and (ii) appointment as Assistant Processor.

Category-3: Eligible for admission to Ph.D. programme only and not for the award of JRF or appointment as Assistant Professor

For admission to Ph.D. in Population Studies at IIPS-Mumbai, clearing in UGC/CSIR-NET 2024 onwards in the subject of Population Studies / Anthropology / Economics / Geography / Psychology / Political Science / Social Work / Sociology / Mathematics / Statistics/Social Medicine & Community Health is the mandatory eligibility requirement.

Candidate who have already passed the qualifying examination and those who have already appeared/shall be appearing in the final qualifying examinations are eligible to apply. However, admission of the candidate will be cancelled if s/he fails to furnish the final examination result by September 30, 2025.

The upper age limit is 30 years as on June 30, 2025. Marks and age will be relaxed for candidates belonging to SC/ST/OBC/PWD categories as per Government of India rules.

Duration: Three years' full time to a maximum of six years. Duration is specified for thesis submission and not for fellowship. The Pre-Ph.D. course work (eight months duration) shall be compulsory for the candidates admitted to the Ph.D. programme.

Fellowship: Government of India Fellowships @ Rs. 37,000/- per month for 1st and 2nd years and Rs.42,000/- per month for 3rd and 4th years available for the Indian students who have qualified NET for Lectureship in Population Studies or its inter-disciplinary subjects conducted by the UGC. Such Ph.D. fellowship also carries a contingency grant of Rs. 10,000/- per year for the first two years and Rs. 20,500/- for the third and fourth year.

Selection Criteria:

- (1) For those students who are having a valid JRF, the selection will be done based on the personal interview only. The personal interview component carries 100% weightage. The Institute will not bear any travel expense of the candidates called for the personal interview. (Eligible for UGC- JRF fellowship only)
- (2) For those students with category 2 and category 3 of UGC-NET 2024 onwards, 70% weightage is given to their NET score and 30% weightage is to their performance in the personal interview. The Ph.D. Admission will be based on the combined merit of NET score & the scores obtained in the personal Interview. The Institute will not bear any travel expense of the candidates called for the personal interview. **Those students who have cleared only NET prior to 2024 are not eligible to apply for any of the Ph.D. programmes.** (Eligible for GOI fellowship only)

Reservation: Reservation for SC/ST/OBC/PWD/EWS will be considered as per the Government of India norms.

Eligibility: (1) Candidates who have completed:

i. A 1-year/2-semester master's degree programme after a 4-year/8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institution.

A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the UGC from time to time.

Provided that a candidate seeking admission after a 4-year/8-semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the UGC from time to time.

OR

ii. Candidates who have completed the M.Phil. programme with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of educational institutions, shall be eligible for admission to the Ph.D. programme.

A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the UGC from time to time.

CAMPUS LIFE

Our campus provides an ideal environment for young minds to explore new ideas, encourage creativity and independent thinking. The activities and resources here are centered around a health and wellness lifestyle. At IIPS, students will be part of the diversity along with international exposure and will have a new experience of learning.

HOSTELS

The Institute has two hostels for accommodating students admitted to various courses. Hostel rooms are furnished and have adequate living and working space. LIBRARY

The library is a part of **One Nation One Subscription (ONOS)** which provides access to 30 prominent e-journals/databases and it also has access to some of the best e-resources and databases, **such as JSTOR, SCIENCE DIRECT, SCOPUS, Wiley, INDIASTAT, UN Database**, etc., and other leading publishers' online collections relevant to health and population sciences.

The Library provides remote access through iProx21 to access online databases, journals and Institutional repositories to its authorized users.

The IIPS library has an institutional membership with **INFLIBNET**, **DELNET**, **IASLIC**, etc. The Institute is an active member of **INFLIBNET-Shodhganga**. The Library have access to Drillbit Software for Plagiarism checking to ensure research integrity.

The Library is fully automated. It uses an RFID (Radio Frequency Identification) facility for the issue/return of books, journals, and reprints. The Library has a reading hall with a seating capacity of 100+ individuals equipped with comfortable furniture, study carrels, centralized air conditioning, and a Wi-Fi facility.

FELLOWSHIP

All the selected Indian student in post graduate programme will be awarded a Government of India fellowship @ Rs. 5000/- per month. In case of Ph.D student, GoI/UGC Fellowship will be awarded to the selected students under GoI/UGC category.

MENTOR – MENTEE

The Institute having a mentor mentee mechanism to support students community in various aspects such as
