MINUTES OF THE EIGHTY SIXTH MEETING OF THE STANDING FINANCE COMMITTEE (SFC) OF THE INTERNAIONAL INSTITUTE FOR POPULATION SCIENCES (IIPS), MUMBAI.

The Eighty sixth meeting of the Standing Finance Committee (SFC) of International Institute for Population Sciences (IIPS), Mumbai was held at 11.00 a.m. on 23th December, 2020 through virtual mode. The meeting was Chaired by Dr. Dharmendra Singh Gangwar, Additional Secretary & Financial advisor, Ministry of Health and Family Welfare, Government of India and Chairperson Standing Finance Committee, IIPS. The list of participants of the meeting is provided at Annexure-I

The Agenda points discussed in the meeting is provided at Annexure-II.

The decisions on the Items wise agenda points are as follows:

- 1. In Item No.1, the minutes of the 85th meeting of the SFC of the International Institute for Population Sciences, Mumbai held on November 16th 2019 and as approved by the Chairperson, were circulated among the members and minutes were confirmed.
- 2. In Item No. 2, the SFC noted the action taken on 85th meeting of the Standing Finance Committee meeting of IIPS. Mr. Bhageria, Chartered Accountant, mentioned that IIPS currently maintains main accounts and project account separately. Project accounts are for specific period and purpose. The accounting systems of both the accounts are different. The main account follows mercantile accounting system whereas project account is cash based accounting system. Hence combining both these accounts as suggested in the 85th meeting of the SFC is not possible. He suggested that the present system is correct and may be continued.
- 3. In Item No.3, the SFC recommends to place before the Executive Council the Audit Report and Audited Annual Accounts of IIPS main account for the year 2019-20.
- 4. In Item No. 4, the SFC recommends to place before the Executive Council the Audit Report and Audited Annual Accounts of sponsored projects funded by the outside agencies for the year 2019-20.
- 5. In Item No. 5, the SFC approves and recommends to place before the Executive Council the Revised Estimate for the year 2020 21to the tune of Rs.60.09 crore for the institute as per details submitted in the Agenda:
 - a. Grant-in-aid General

P.s. 2088.50 (Lakh) b. Grant-in-aid for Creation of Capital Assets Rs. 2544.00 (Lakh)

c. Grant-in-aid Salaries

Rs. 1376.66 (Lakh) Rs. 6009.16 (Lakh)





Chairperson instructed that from next meeting an analysis of the ongoing expenditure and the likely demand for the remaining months of the financial year may be included as an agenda.

6. In Item No. 6, the SFC approves and recommends to place before the Executive Council the Budget Estimate for the year 2021-22 of Rs.109.58 crore for the institute as per details submitted in the Agenda.

- 7. In Item No. 7, the SFC approves to run the EMS department for the year 2020-21 with the budget provisions of Rs 27.54 lacs as mentioned in the detailed agenda on project basis and recommends to place before the Executive Council.
- 8. In Item No. 8, the SFC approves the proposal to increase the sitting fee to official/non official members/experts as per the OM No. 21-1/2015(FD-I/B dated 08.01.2018) of UGC, from Rs. 2000/ to Rs.3000/ per meeting subject to maximum of Rs 5000/ per day irrespective of number of meetings in a day for IIPS and recommends to place before Executive council.
- 9. In Item No. 9, the SFC did not approve the proposal to increase the remuneration of Medical Doctors. The enhancement as approved in Executive council earlier may be continued.
- 10. In Item No. 10, the SFC considered the proposal to increase the number of Ph.D. seats in lieu of M.Phil. fellowship due to closing the M.Phil. programme from 2021-22 academic year During the discussion Chairperson sought clarification on the availability of Ph.D seats among faculty in line with the UGC norm. Director and Sr Professor clarified that the ratio as per UGC norms is maintained and there are vacant seats available among faculty members. After discussion the committee recommends to increase 10 (Ten) additional Ph.D. seats in lieu M.Phil seats which will have no additional financial implications. Chairperson also suggested that separate proposal may be forwarded to the Ministry if Institute desires to have more Ph.D seats due to closing of M.Phil programme.



- 11. In Item No. 11, the Chairperson instructed that a power point presentation of revised bye-law may be made before the bye-law committee for finalization and recommending to place before the Executive Council.
- 12. In Item No. 12, the SFC discussed the reporting items. The SFC noted the recommendation of the Academic Council on the revision of fee for all the courses. The extension of fellowship to 6 Ph.D students for the firth year are noted and recommended to place before the Executive Council. The progress in acquiring Mumbai Port Trust Land adjacent to IIPS was also noted.
- 13. While discussion on Additional Agenda Item No 1, on the enhancement of proposal of post-Doctoral fellowship amount from Rs 50000/- to 70000/- the committee did not approve the enhancement. However, the SFC approved to provide HRA to postdoctoral scholars as in the case of Ph.D. students at the rate of 24% (Mumbai based).
- 14. The Chairperson also suggested that IIPS may undertake short term training programme for both in-service as well as for others sectors on survey research and methods, data analytics etc. The chairperson further mentioned that a brochure of the Institute with its core areas of strength in survey research and data analysis etc may be prepared. The Director and Senior Professor informed the Committee that the Restructuring Committee appointed by the EC has submitted its report proposing a new Department of Survey Research and Data Analytics and is under consideration of the Ministry.

The meeting ended with vote of thanks to the Chair.
