

## SOP for selection of student interns for field monitoring of NFHS-6 main survey data collection

Applications are invited from Ph.D. students of different Universities for the post of field monitoring intern in their respective states. There are two positions per state/group of state/UT and the post is purely on a temporary basis for a maximum duration of six months in the project **National Family Health Survey (NFHS-6)**. The **NFHS-6** is sponsored by the Ministry of Health and Family Welfare, Government of India and being implemented in each of 37 States/Group of States/Part of States and UTs.

Any Ph.D. student willing to apply for the position of intern should apply to join the IIPS data quality monitoring team. After selection, the candidates may be required to attend four weeks of state level training for the main survey for research investigators at state headquarters. This is a mandatory condition for the NFHS-6 data quality monitoring and hence all the student interns will have to carry out the data quality monitoring after undergoing through a comprehensive training. Also, it is essential that the person applying for the post should have good knowledge of the local language.

IIPS may choose student interns based on an online personal interaction to assess the suitability of interns for the field work monitoring and their willingness to participate in such strenuous task.

**Instruction for applicant:** The candidates are informed that all above posts are purely on temporary basis. The selected candidate will be provided offer letter for **a maximum period of 6 months starting from the state level training**. IIPS reserves the right to terminate the appointment of any intern if he/she is not regular in attending the training or participation in the field monitoring.

The interested candidates are requested to apply using the prescribed application form on or before June 15,2023 . The dully filled application should have a copy of their recent CV, copies of the degrees, certificates and other relevant documents, especially published research papers, experience certificate, recent photo and Aadhar/Pan Card.
